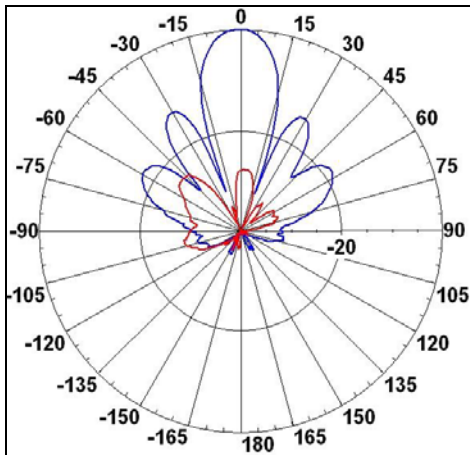

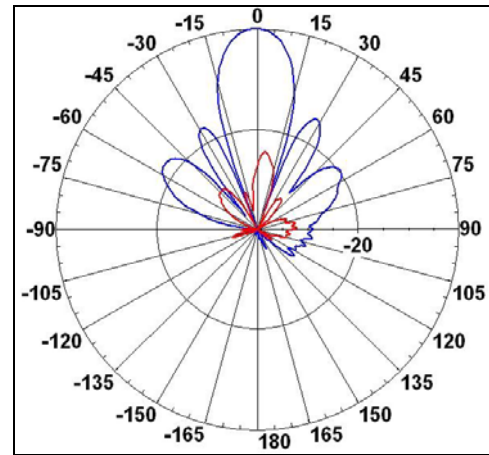

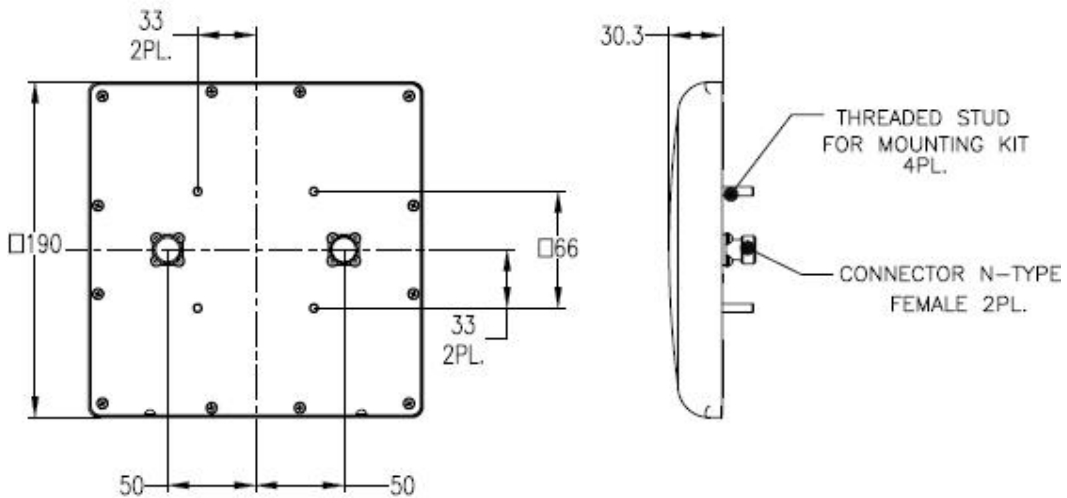
Azimuth Radiation Pattern
